• The Council has not provided adequate explanation of variances between 2022-23 and 2021-22 accounts as required Annual Governance Statement I am unable to conclude whether or not the Annual Governance Statement is consistent with the Council's internal controls and governance arrangements for the year. (Information was provided on variances between budget/spending and no request for further information was received. The Clerk has written to the auditors asking them for details of what they want so that this can be closed off)

• Assertion 3: The Council holds significant sums of money in reserves. The Council has not provided a copy of its budget to demonstrate that it calculated its budget requirement in accordance with the Local Government Finance Act 1992m, taking into account its accumulated reserves.

(In summary we are holding too much in reserves – should hold no more than 1 year's precept/budget).
